Through innovation and collaboration, it aligns itself to the principles of regeneration of materials and value creation via processes, products and services, with a view to prolonging the life cycles of products and efficient use of resources. This model includes innovative solutions and it seeks to optimise production of goods while curbing consumption, excess materials and waste via participatory approaches, according to extended time windows that short-term visions do not contemplate.

Italian Circular Economy Stakeholder Platform

The European Commission and the European Economic and Social Committee favoured the formation of ECESP (European Circular Economy Stakeholder Platform) in November 2017, which is joined by the Italian national agency for new technologies, energy and sustainable economic development, ENEA (Italy's sole representative), as a member of the Coordination Group. ENEA promoted a mirror national initiative, the Italian Circular Economy Stakeholders Platform (ICESP) with the aim to create a point of national convergence on initiatives, experiences, critical issues, perspectives and expectations on the circular economy that the Italian system wants and can represent in Europe with a single voice, promoting the Italian way for circular economy. ICESP involves and is open to the participation of Italian stakeholders from industry, institutions, research and civil society, active and interested in the transition towards circular economy, capable to represent a significant set in their reference sector.

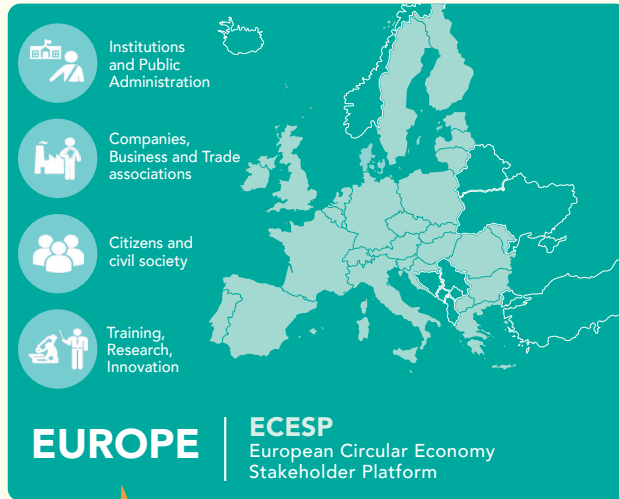
The initiatives of the platform reach out to a number of players, including public administration bodies, business associations, public and private research, and academic and civil society.
